As always, nominations will be accepted from the floor at the time of the elections.

# Who Carries Out Our Mission?

Finally, I would like to tell you about the concerns of the Pediatric Section over the past several months. Most of what your officers have been working on is related to the development of the numerous educational programs for the membership. As you know, the primary mission of the AANS/CNS Section on Pediatric Neurological Surgery is its educational mission. We are constantly being asked to provide printed and electronic materials, program ideas, reviewers, and speakers for a wide variety of publications and meetings. Ann Marie Flannery, MD, has expanded the membership of the Education Committee, which has been given the responsibility for much of this work. Despite this, volunteers are still needed. Many of these projects involve a substantial amount of time and effort, but they are critical to advancing the longterm mission of the Pediatric Section. The Executive Committee will be considering several new and expanded committee assignments at its meeting in Scottsdale. 

# Joining California Neuro Alliance Aids Advocacy

Advocacy is one of the three primary goals of the Hydrocephalus Association. Toward that end, the association recently participated in the second annual Advocacy Day sponsored by the California NeuroAlliance in Sacramento, Calif. Longstanding Hydrocephalus Association board member and healthcare advocacy veteran Cynthia Solomon has been responsible for getting the association more actively involved in healthcare policy development and consumer advocacy in recent years.

The California NeuroAlliance began as a pilot project of the American Academy of Neurology. It is a diverse coalition of voluntary health organizations, physicians, and other healthcare professionals throughout California. Organizations include United Cerebral Palsy Association, Epilepsy Foundation, Brain Injury Association of America, Alzheimer's Association, and others. The alliance is dedicated to promoting access to quality healthcare through education, public awareness, and advocacy.

# About California Neuro Alliance

The California NeuroAlliance has identified a number of primary concerns affecting persons with neurological conditions. In particular, it plans to address:

- limited drug access; closed formularies;
- out-of-pocket costs for the care of chronic neurological conditions;
- access to specialist physicians;
- insurance coverage (if covered and level of coverage);
- access to community resources about neurological conditions;
- employment situations of persons with neurological conditions.

Alone, the Hydrocephalus Association represents a relatively small number of voters. Alone, the association does not have the clout to meet with senators and assembly members. Alone, it does not have the person-power or the expertise to effectively track and comment on relevant legislation.
